# **Application for Foreign Nonprofit Corporation Application for License**

This form should be used to apply for a license to do business as a foreign nonprofit corporation.

Please select the appropriate box to indicate whether the application is being made to obtain a temporary or a permanent license. A temporary license allows a corporation to transact business in Ohio for a period of six months. Pursuant to Ohio Revised Code §1703.13, no foreign corporation shall be granted more than two temporary licenses within any period of three years. A permanent license allows a corporation to transact business in Ohio until the license is cancelled or surrendered. ## **Certificate of Good Standing**

# **Original Appointment of Statutory Agent**

Pursuant to Ohio Revised Code §1703.41, a foreign nonprofit corporation that is licensed to transact business in Ohio must appoint and maintain an agent to accept service of process on behalf of the corporation. The statutory agent must be one of the following: (1) A natural person who is a resident of this state; or (2) A domestic or foreign corporation, nonprofit corporation, limited liability company, partnership, limited partnership, limited partnership association, professional association, business trust, or unincorporated nonprofit association that has a business address in this state. If the agent is a business entity then the agent must meet the requirements of Title XVII of the Revised Code to transact business or exercise privileges in Ohio.

By completing and signing the form, the corporation agrees to the statements listed below the statutory agent appointment. This gives consent to service of process on the agent so long as the authority of the agent continues. Also, the corporation agrees to service of process upon the secretary of state if (1) the agent cannot be found; (2) the corporation fails to designate another agent when required to do so; (3) or the corporation's license to do business in Ohio expires or is cancelled.

## Incorporating to Prosecute or Defend Legal Action

Pursuant to Ohio Revised Code §1703.29(A), the failure of a foreign corporation to obtain a license in Ohio does not affect the validity of any contract formed by the corporation. However, a foreign corporation which should have obtained a license must file for a license and pay an additional \$250 fee in order to prosecute or defend any legal action arising at the time it was not licensed to transact business in this state.

#### Corporation that has been Transacting Business in Ohio Without a License

If the corporation began transacting business in Ohio prior to 2009 without obtaining a license, the corporation must attach a certificate from the tax commissioner which states that the corporation has paid off all franchises taxes which it should have paid had it qualified to do business in Ohio at the time it began to do so. The tax department refers to this as a "D4 Certificate" and it may be obtained by contacting the Ohio Department of Taxation at 1-888-405-4089.
